.00 through .499 will round down

.500 through .999 will round up

If after rounding we are short a slot due to several clubs rounding up, the club with the number of slots closest but not less than .50, will round down instead of up. Likewise, if after rounding we have an extra slot due to several clubs rounding down, the club with the number of slots closest to but not more than .499, will round up instead of down.
